**RE: Start of improvement works on Anstey Lane – Traffic Management & Diversions**

We write to advise that works to construct improved pedestrian and cycle facilities on Anstey Lane will start on 14<sup>th</sup> June 2021 and are expected to take around six months to complete. To keep disruption in the area to a minimum it is planned to carry out the works in a series of phases. The first phase of the works will be to widen the footway to create a shared cycleway on the south footway of Anstey Lane.

Plans for an experimental closure on Buckminster Road and a short length of bus lane on Anstey Lane are in development. On street notices will be placed on Buckminster Road to notify the residents of the experimental closure proposals and on Anstey Lane regarding the bus lane, in due course.

During the works a one-way closure of Anstey Lane inbound between Krefeld Way and Buckminster Road will be required. A clearly signed diversion route will direct inbound traffic along A563, Groby Road, and Blackbird Road. Local residents in the Darenth Drive and Great Meadow Road and the surrounding area will be able to access their properties via Strasbourg Drive, Heacham Drive and Calver Hey Road or other local routes you may ordinarily use.
